Thus, the visit to the Khadakpada Police Station provided valuable insights into its operations and community engagement efforts.

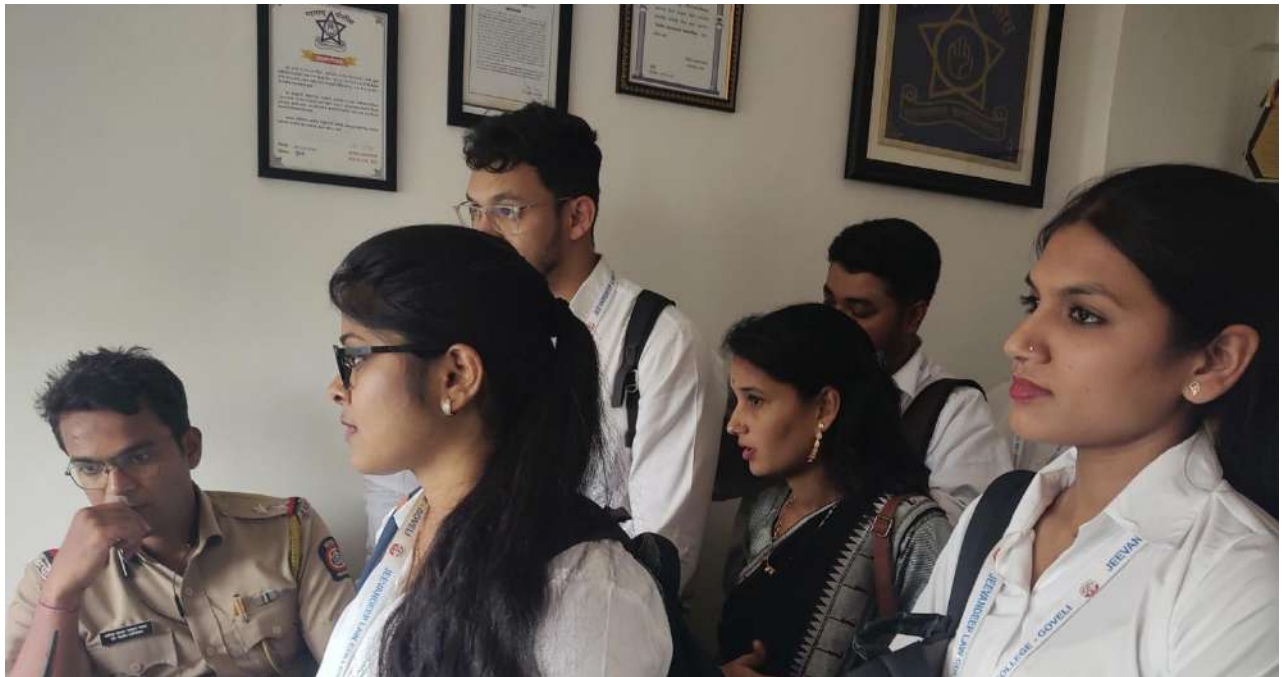

2. Women Help Desk – To make the women feel secured and more comfortable a separate women help desk has been conducted.
3. Duty Officer – Duty officer is a person who lodges a FIR and tells the respective officer about the report. He maintains daily diary and puts entry in the diary.

Court Visit

Location – Kalyan

Purpose of the visit:

The purpose of the visit was to understand the working of a court, the nature of duties of the judicial officers. The visit was to help the student in understanding the role of court in dispensing justice in any case, the role of prosecutors in a case, the way cases proceed in a court, the way judges, prosecutors and defense lawyers handle the case, the relationship of the prosecutors and the police.

The day started with a brief note given to the students about the Court and court rooms. The students visited different Court Rooms and observed Court Proceedings.

The visit enlightens the students with such facts which brought out the difference in the proceedings between the Metropolitan Magistrate Court and Hon'ble High Court as well as for explaining the difference in the jurisdiction.

Observations:

How cases are handled – Case presentations, Lawyers present their arguments and evidence to the judge and after hearing both the parties judge gives a decision.

Public Role – People can watch the court proceedings from a designated area but should maintain the decorum.

Observation

Report on Moot Court Competition

The Moot Court Competition held on 7th June, 2019 was an engaging and intellectually stimulating event where students showcased their advocacy skills in court room environment. The competition was structured to stimulate a real appellate court proceeding, with teams arguing both sides of hypothetical legal case.

The competition comprised several rounds including preliminary rounds, semifinal and final round. Each team was required to prepare written submission (Memorial) and delivered oral arguments before panel of judges composed of legal professional and academics. Judges evaluated the team based on criteria such as legal analysis and clarity of argument.
