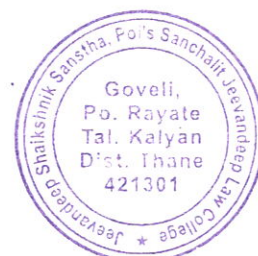
### **Planning and Structure**
