WORKSHOP ON LEGAL RESEARCH AND RESEARCH PAPER WRITING

The program commenced with National Anthem and was followed by the welcome address by Mr. Yogesh S. Sardar Sir Principal, Jeevandeep Law College, Goveli. During the welcome address sir expressed his view that legal research and research writing is important for academicians, lawyers and students those who are pursuing for higher education.

Then the sir introduce to the eminent speaker to the participants. Dr. Dinesh Gupta addressed the participants on the topics, Introduction to Legal Research and literature review and problem verification. In his speech he discussed in detail and key highlights points:

- Legal research involves finding and analyzing laws, statutes, regulations, case law, legal precedents, and other legal sources to answer specific legal questions.
- Introduce the topic, state the research question, and present the thesis statement. Provide background information to set the context.
- The difference between methods of research and methodology of research was discussed with examples.
- It can even be a discovery or invention that can be proved scientifically or logically.
- Different kinds of research was discussed and the speaker urged the participants to be specific and focused on the topic.
- Review existing literature and legal sources to demonstrate the current state of knowledge and identify gaps or areas of contention.
- Explain the research methods used, including the type of sources consulted and the approach to analysis.
- Present the main arguments, supported by evidence from legal sources. Analyze different perspectives, case laws, and interpretations.
- Summarize the key findings, restate the thesis in light of the discussion, and suggest recommendations or areas for further research.
- The importance of testing the hypothesis and interpreting the data is a skill to be developed in research.

The session was followed by the Question Answer Session. At the end vote of thanks given to the Dr. Dinesh Gupta.

Sir made a comprehensive understanding of writs and Public Interest Litigation (PIL) is a legal mechanism in India that allows individuals or organizations to file lawsuits in the interest of the public, especially when the rights of marginalized or disadvantaged groups are at stake focusing on their significance, application, and practical implications in the legal system. He /she explained that this session was designed for students and future legal professionals.

Further sir explained in detail about the five types of writs and how they are important for writ however, he started explaining about the PIL. he said A legal action initiated to protect or enforce the rights of the public or a significant segment of society, rather than individual interests. **Dr. Yewale further explained the Steps to file a PIL in various courts, including the Supreme Court and High Courts.** Participants engaged in role-playing exercises to draft and present writ petitions and PILs.

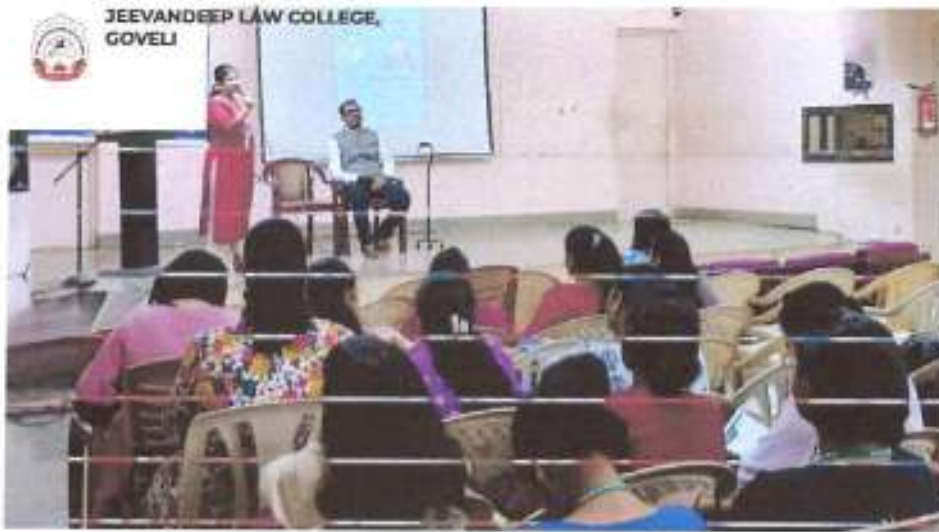

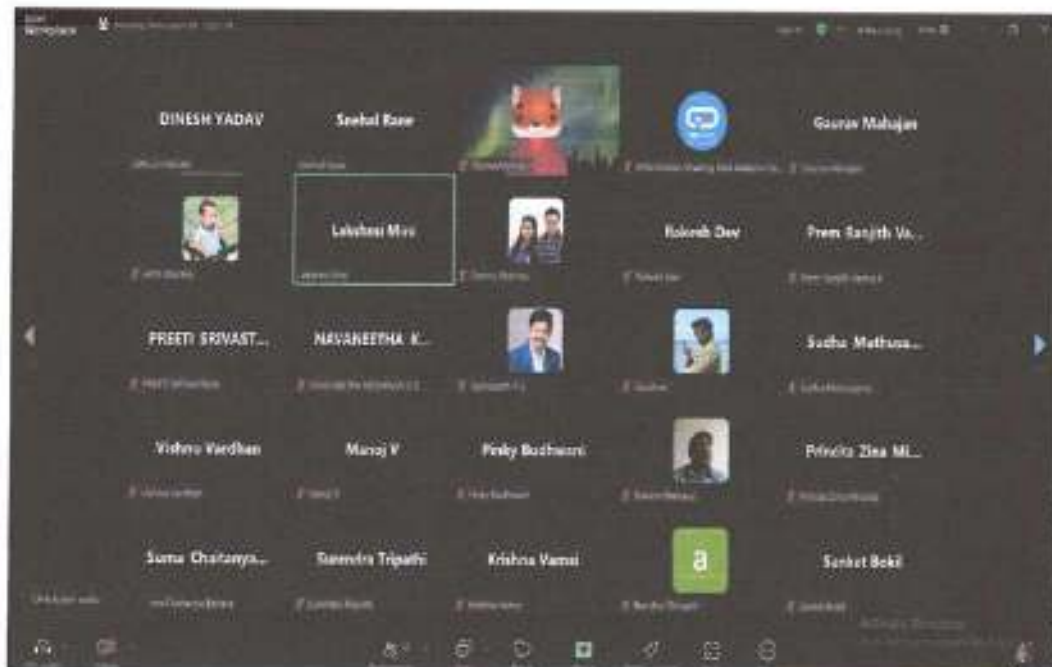

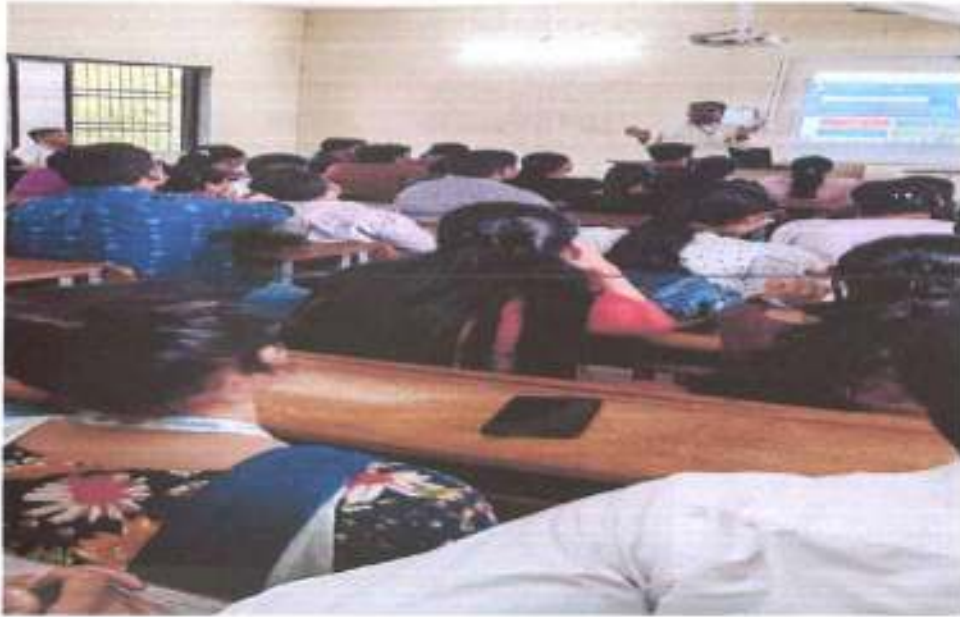
