- 1. Prevention of sexual harassment:** Develop and implement policies and procedures to prevent sexual harassment within the institution. Conduct regular trainings and workshops to educate students and staff about sexual harassment, its consequences and reporting mechanisms. Ensure a safe and supportive environment for all women by addressing and resolving complaints promptly and fairly.
- 2. Promoting gender equality:** Promote a culture of gender equality and respect throughout the institution by organizing information campaigns and discussions on gender issues. Develop initiatives to promote equal opportunities and fair treatment of women in all aspects of academic and administrative life.
- 3. Provision of support and remedial mechanisms:** • Establish clear guidelines and channels for redressing grievances related to sexual harassment and gender discrimination. Offer victims confidential support services, including counseling and legal assistance. Regularly review and update complaints mechanisms to ensure they remain effective and accessible.
- 4. Creating awareness and advocacy:** Organize seminars, workshops and lectures to raise awareness of women's rights, gender issues and the effects of discrimination. Collaborate with external organizations, including NGOs, to increase advocacy efforts and provide additional resources.
- 5. Promoting Participation and Empowerment:** Encourage active involvement of students, faculty and staff in WDC activities and initiatives. Facilitate training programs and workshops aimed at empowering women in skills for personal and professional growth. Support self-employment and business initiatives to increase the economic independence of women.
- 6. Monitoring and Evaluation:** Regularly evaluate the effectiveness of WDC policies and activities to ensure they meet the needs of the institution's female population. Collect and analyze data on cases of sexual harassment

and gender-based discrimination to inform policy adjustments and improvements.

7. Collaboration and Networking: Establish partnerships with local, regional and national organizations working in the field of women's development and gender equality. Engage various stakeholders, including government bodies and community groups, to promote the goals of the WDC.

8. Promoting health and well-being: Ensure that the work environment supports the health, hygiene and well-being of female students and staff. Hold health seminars and provide information about available resources to support mental and physical health.

9. Institutionalizing gender sensitivity: Work to integrate gender sensitivity into institutional policies, curricula and daily practice. Advocate for the inclusion of gender studies and related topics in academic programs to build awareness from an early stage.

It is suggested that the impart practical experience to our students visit Bar Council of India & state of Maharashtra and public office are essential and the same was approved.



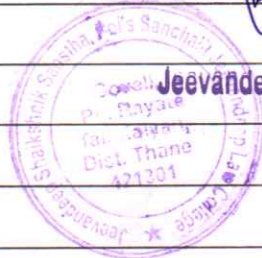
3) Library :-


