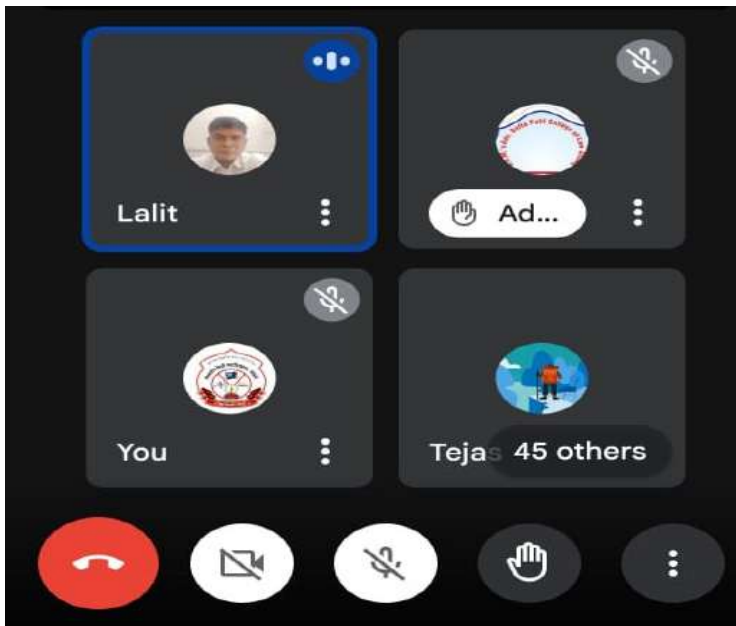

### Seminar on Procedural laws

**Topic** – Seminar on Procedural laws

**Guest Speaker** – Prof. Subash Sonkar Sir

#### **Objectives of seminar**

- To prevent delaying the investigation and trial process.
- To ensure attendance of any person concerned with a case with the various available measures like warrant, summons, attachment of property, proclamation, etc.
- To punish the wrongdoer and to deter him/her from repeating the commission of the crime again.

The Criminal Procedure Code, 1973 refers to working of the criminal justice system from the commission of a crime, investigation of crime and until the sentence against the accused is passed and the case is closed. With the aid of several examples and important cases, Sir explained the nuanced distinctions between Investigation and Inquiry and their significance in court proceedings. Sir discussed the statutory law relating to trial and punishment along with the practical aspects of jail and life of a prisoner.

All the students of our college were the beneficiary of the Guest Lecture conducted on Criminal Procedure Code. Thus lecture was ended with vote of thanks. Total no. of 46 student attended the seminar.

- Identify the stages in investigation and procedure of trial in criminal cases.
- Understand the procedural nuances of criminal court inquiry and trial.
- Make the distinction between different types of trials provided under the code.
